# Briggs Elected 2019 Chairman of Indiana Bankers Association

In addition to serving on the boards of Bank of Geneva and Limberlost Bancshares Inc. as chairman, Briggs serves the community in the following capacities: Indiana State Museum, treasurer; Limberlost State Historic Site, corporate secretary; Limberlost Conservation Association, treasurer; Northeast Indiana Regional Development Authority, chairman; Title Center of Indiana LLC, director; Adams County Community Foundation, vice president; Adams County Economic Development Corp., treasurer; and Adams Public Library System, treasurer. Additionally, Briggs was appointed in 2017 to the Indiana Board of Depositories. Past directorships include the Geneva, Indiana Town Council; Northeast Indiana Regional Partnership; South Adams Trails; Swiss Village Inc.; Adams-Wells Crisis Shelter; and Arts Place Inc. He has served on the IBA board as first and second vice chairman and as northeast region director. Briggs is a graduate of Ball State University and a member of the IBA 40 Year Club.
