

# Indiana BANKPAC Silent Auction Donation Form



The 2025 Indiana BANKPAC Silent Auction, hosted by the IBA Future Leadership Division, will be held at the IBA’s Annual Convention on September 8 at French Lick Resort. Bidding will be open to everyone, whether or not you plan to attend the Annual Convention. We are seeking monetary and item donations from state-chartered banks, associate members and individuals. Monetary donations, as well as the purchase price of any item donations, count toward 2025 fair share goals for banks or diamond status for associate members, and all proceeds from the silent auction go directly to the Indiana BANKPAC State Fund. Popular items from past auctions have included unique artwork, golf items/passes, electronics, liquor, sports/concert tickets, purses, gift cards, children’s toys and jewelry.

Item donations will be reported to State Campaign Finance as in-kind contributions to Indiana BANKPAC. Monetary donations will be reported as general contributions to Indiana BANKPAC. Federally chartered institutions are prohibited from making corporate contributions to Indiana BANKPAC, but individual donations are welcomed from those institutions. You have the right to refuse to contribute without any reprisal. The suggested amounts are only suggestions; more or less than the suggested amounts may be given, and the amount given or the refusal to give will not benefit or disadvantage the individual being solicited. State law requires Indiana BANKPAC to use its best efforts to collect and report the name, mailing address, occupation and name of employer for each individual whose state contributions exceed \$100 in a calendar year. Contributions to BANKPAC are not tax deductible as charitable contributions for federal income tax purposes.
